

ORDINANCE NO. 3767

AN ORDINANCE ANNEXING LAND TO THE CITY OF HAYS, KANSAS.

WHEREAS, the following described land adjoins the City of Hays, Kansas,

WHEREAS, written consent for annexation of the following described land, signed by all of the owners thereof, has been filed with the City of Hays, Kansas, pursuant to K.S.A. 12-520; and

WHEREAS, the governing body of the City of Hays, Kansas finds it advisable to annex such land.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HAYS, KANSAS:

Section 1. Pursuant to K.S.A. 12-520(a)(7) the following described land is hereby annexed and made part of the City of Hays, Kansas:

That part of the Southwest Quarter of Section 1, Township 14 South, Range 18 West, of the 6th Principal Meridian, Ellis County, Kansas, described as follows:

Commencing at the Northwest corner of said Southwest Quarter; thence on an assumed bearing of North 89 degrees 54 minutes 55 seconds East, along the north line of said Southwest Quarter, a distance of 82.04 feet to the intersection of said north line with the east right of way line of Commerce Parkway; thence South 00 degrees 37 minutes 40 seconds West, along said right of way line, a distance of 208.71 feet to the point of beginning of the land to be described; thence North 89 degrees 54 minutes 55 seconds East, parallel with the north line of said Southwest Quarter, a distance of 750.00 feet; thence South 00 degrees 37 minutes 40 seconds West, parallel with the west line of said Southwest Quarter, a distance of 450.00 feet; thence South 89 degrees 54 minutes 55 seconds West, parallel with the north line of said Southwest Quarter, a distance of 750.00 feet to a point on the east right of way line of Commerce Parkway; thence North 00 degrees 37 minutes 40 seconds East, along said right of way line, a distance of 450.00 feet to the point of beginning. This tract contains 7.747 acres.

Section 2. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.

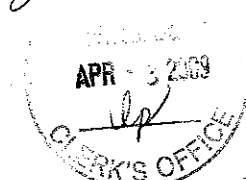
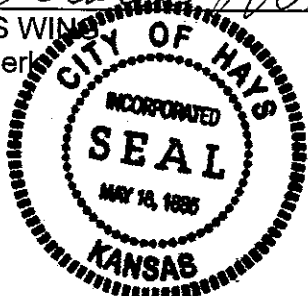
