**2016 W-2 SPECIFICATIONS FOR ELECTRONIC FILING
 COMMA SEPARATED VALUE (CSV) FORMAT**

The Kansas Department of Revenue (KDOR) accepts W-2 withholding statements in the *EFW2 – Specifications for Filing Form W2 Electronically* format outlined by the Social Security Administration (SSA). For more information about the EFW2 including Kansas-specific requirements, refer to the *K-2MT Specifications for Electronic Filing* available on the Department’s website, www.ksrevenue.org/forms-btwh.htm.

In instances when a filer cannot meet the SSA guidelines but can put required data in a spreadsheet format, KDOR will accept withholding data in the W-2 Comma Separated Value format described below.

Kansas does not accept withholding information submitted on magnetic media. Filers submitting information for multiple employers should contact the Department’s Electronic Services unit for filing options.
